## 1. Apologies for Absence

Apologies for absence were received from Councillor Kathleen Martin, PC Barry Ritchie and PC Barry Reiter.

#### 2. Declarations of Interest

None declared.

# 3. Minutes of Meeting on 29<sup>th</sup> May 2019 and Special Meeting 24<sup>th</sup> July 2019

The revised minutes (issued 3<sup>rd</sup> September) of the meeting of 29<sup>th</sup> May 2019 were accepted, without amendment, proposed by JB, seconded by PT.

The minutes of the Special Meeting, regarding the development of site H49, of 24<sup>th</sup> July 2019 were accepted, without amendment, proposed by PW, seconded by JJ.

# 4. Matters Arising

There were no matters arising from either set of minutes.

# 5. Police Report

In PC Reiter's absence, MRW presented the Police Report for the period since the last meeting, noting there had been no crimes reported in the area. No comments were arising and the Report was accepted.

JA thanked PC Reiter for his Report and added that people should note any suspicious activities they may see.

# 6. Muckhart Community Plan: Update

JA thanked all of the Community Plan Leaders for their various updates to the Muckhart Community Plan which had now been updated and copies circulated. The 2019 Annual Progress Report has also been produced (this is appended below, for information).

A few updates to specific items in the MCP were reported:

# Sustainability: S-2 Lead JJ

JJ noted that he had been in contact with Kevin McKeown, the Home Energy Officer at the Council, regarding energy saving initiatives and to agree a meeting to be held in Muckhart on September 18<sup>th</sup> (6:30pm to 8:30pm) to cover this subject. He had also been in contact with the Fire Services who would like to demonstrate, to the community, the use a defibrillator and to discuss fire safety issues. These two events could possibly be combined. JJ would confirm the meeting, by Friday of this week. In response to a query, he noted that the free energy saving assessments, provided via the Council, were advisory and did not have any legal force but that there were many, commercially available, assessments which did have legal force.

## Sustainability: P1 Lead PL

PL noted that the CCTA was still active and that a further meeting had been arranged for 27<sup>th</sup> September which he planned to attend. He noted that the timing of this meeting may be quite fortunate, as he was aware of an initiative from Perth and Kinross Councillor Barnacle to establish a Kinross Community Transport Association. He would follow up on this and determine if the two initiatives could be connected.

#### 7. Planning Sub-Group

## A: H49 and Springfield properties update

SD reported that MCC had submitted a response to the Council, objecting to the development of 50 houses on site H49 as proposed by Springfield Properties. In all, just over 50 objections had been submitted to the Council from the community which provided an excellent representation of the range of community views. This application now sits with the Council's Planning Department which has started its process of determination of a recommendation to the Council.

SD noted that MCC's Planning Group had met with Allan Finlayson and Grant Baxter, of the Planning Department, and had a wide-ranging discussion of the various issues raised. The

Planning Department had noted that some responses from formal consultees were still coming in, including one from SEPA. Among the issues discussed was that of the "urbanisation" of the village and the positioning of the affordable homes within the site but the key issue to be determined is that of the number of houses proposed, namely, 50 instead of 35, as specified in the Council's Local Development Plan. He felt the group had established a good relationship with the Planners.

A further meeting is to be arranged with the Planners, for the beginning of October, giving time for Council to discuss the application with Springfield and for the outstanding reports to be submitted.

# B: Revised Local Development Plan (LDP) and Main Issues Report (MIR)

SD noted that we continue to await the Main Issues Report and its approval by the Council prior to it being issued for consultation.

# C: Arndean Estate – Woodland Proposal

SD noted that Scottish Forestry (SF) require an issues report to be maintained, regarding forestry development applications, which includes comments from consultees and proposals to address any objections. He had now obtained a copy of the report from SF, for the Arndean proposal, and he had also received a revised plan of the development from Tilhill, Arndean's agents, which have been distributed.

PL, MP and SD all noted that they had additional comments to make on the revised plan. It was agreed to reconvene the Sub-group to submit further comments to SF/Arndean regarding, for example, paths, the proposed layout, etc. (though it was noted that it is not clear when current consultation process concludes).

## **D: Recent Planning Applications**

SD noted that, since our last meeting, 8 further applications had been made and that MCC had responded to 7 of these (the 8<sup>th</sup> was very recent and had not yet been assessed). 4 of the 8 had been supported (some with comments or suggestions) and 3 had been objected to (including the proposed development of H49). One of these was for Rossarden, which the Council approved, another was for the fencing, erected along the main road, on the boundary of the Conservation Area.

# 8. Muckhart Primary School: Update

VW noted that a parents meeting had recently taken place. She reported that the school roll was now at 49 pupils and that 3 new sets of parents appeared to be interested in sending their children to Muckhart PS. In answer to a question about how the school could accommodate the H49 development, she noted that the maximum capacity of the buildings was for 75 primary pupils.

VW also noted a few dates for community involvement:

• A big tidy up of the school garden (formerly the Community Garden) would take place

on the forthcoming Sunday, 8<sup>th</sup> September, at 1:00 to 3:00pm. Those wishing to help out should take along some garden tools. Tea and coffee would be available

- On Friday 27<sup>th</sup> September, there will be a Harvest Garden show at 2:00pm
- On Tuesday 8<sup>th</sup> October, from 6:30 to 7:30pm, there will be a school Open Evening to which all members of the community are invited to see what the school is doing

It was noted that these dates would be put into the community diary ACTION: JB/MW

VW went on to note that a new outdoor nursery is planned for 2020, using the garden area. She asked for MCC's support for this initiative. In response to a question she said staffing of this was yet to be determined.

In response to a question from MRW, VW noted that there was no change to the issue of parking at the school and that the drop-off and collect times for the nursery would be different from those of the school.

# 9. Treasurer's Report

DC presented the Treasurer's Report, for the period to 1<sup>st</sup> September 2019. The balance of the account stood at £1790.17.

Expenses to PL for the Planning Conference have yet to be reimbursed.

#### **10. JCCF**

DC noted that when it works, the JCCF works well. The next meeting will be on the 12<sup>th</sup> September and all CC members can attend.

It was noted that it appeared that the KHub (Knowledge Hub) was not being particularly well used, perhaps, because it takes the form of a blog site. JCCF members are to determine if this will continue to be utilised.

#### 11. Correspondence

MRW had circulated a list of correspondence received, in a summary format. He noted:

- An email (21/06/2019), from Lesley Baillie, and a potential further change to the Community Council constitution template
- A brief discussion took place regarding whether it was worthwhile continuing to distribute
  all NWS (and some other) communications to all members including those that could be
  considered to be relevant only to specific "locations". Further to MRW's suggestion, it was
  agreed that he would send out some recent examples to members to request feedback on
  whether, or not, a wider distribution made sense

  ACTION: MRW

MW noted that it was not easy to upload some of the emails circulated onto the web-site /Facebook. It was decided to try sending these to MW as jpegs, or in .pdf format, to see if this would solve the problem.

ACTION: MRW / MW

#### **12. AOCB**

VW noted a couple of further dates for the diary:

- A Macmillan Coffee Morning would take place in the Coronation Hall, on Friday 27<sup>th</sup> September, 9:30am - 12:00pm
- The Light up Muckhart evening, would take place on 24<sup>th</sup> November, at 5:00pm.

SD noted that the Burnfoot East Windfarm Community Liaison Group would meet on 12<sup>th</sup> September and that he planned to attend to represent Friends of the Ochils. If any members wished to attend to represent MCC, then they should contact SD

**ACTION: SD** 

SD also noted that the invasive species Himalayan Balsam was taking over large areas locally (e.g. around the green keepers hut, at the golf club, at the community woodland, etc.) and that this issue required some attention. He also noted that this weed could threaten the local SSSI located down from the golf course, it can lead to soil erosion, its seeds disperse widely and its presence has even caused mortgage financing difficulties.

PL noted there was an agreed action, under S1/3, in the revised MCP, to initiate community action on this. It was noted that it was probably too late to take effective action, this year, as the plants were already seeding. PL agreed to research this further and report back to members with a proposed plan.

# Muckhart Community Plan 2017- 2022 Annual Progress report September 2019

Muckhart Community Council (MCC) launched the Muckhart Community Plan in September 2017.

Its aim was to identify, promote and deliver the community's priorities throughout the following 5 years.

I am pleased to report (under the Plan's 8 headings), the progress made during the first 12 months towards achieving the Community Plan's objectives. These are being delivered through our 19 Community Council Action Plans (see Appendix 1 for an example of an Action Plan).

# 1. <u>Image of the village</u>

# **Entry to Scotland in Bloom (V1)**

Peter Wyatt has been leading a working group (which includes members of Amenity Society) to generate interest within the community to progress to a village entry to Scotland in Bloom where entries will be judged on the following;

- Horticultural Achievement
- Environmental Responsibility &
- Community Participation

A significant number of the community have already indicated their support and the immediate priority is to move forward with the following two initiatives to stimulate and generate active interest within the village

- A Keep village tidy day to improve the appearance of the village
- Nature Trail on school the path which will require obtaining appropriate funding

Earlier this year funding for the proposed Nature Trail was applied for through the Calor Gas Community Fund, however this application was unsuccessful, and the priority now is to apply for other local funding, to kick start this initiative.

It is also intended to liaise with the school on this initiative, especially since there may be some helpful links with the proposed external nursey, should that be established.

# Attractive visitor area in the vicinity of the church, including parking (V2)

Muckhart Church supports this initiative and will take the lead on it, when a Working Group will be formed of interested persons from within the community to assess the viability of this project.

However permission from the land owners (The General Trustees of the Church of Scotland) will require to be obtained before the viability of the project can be progressed.

Matthew Pease (Architect) is presently drawing up some ideas for consideration.

Feasibility study into Improving the area on main road and adjacent to Coronation Hall (V3) Whilst the Coronation Hall Committee supports improvement in the area in front of the Coronation Hall (possibly a Village Square) they wished a wider approach taken to any feasibility study.

For example, to take a strategic view of this and other potential projects, in order that they could benefit from "Planning Gain" from the H49 site. This could lead to repositioning the playpark into H49 site, providing an opportunity of introducing a car park (with landowner's permission) into the ex-playpark area, thus, requiring only limited (disabled) parking in front of Coronation Hall. This could be achieved along with a redesigned main street through the village, introducing a "street by design concept".

Therefore the feasibility study into the Village Square concept has not being taken any further (in isolation), and it is anticipated that professional assistance will be required to deliver a more 'strategic' feasibility study which could also possibly benefit from a "Charrette Programme" and the viability of this initiative may depend on significant planning gain from the H49 development.

# 2. Housing Development

# Housing policies and development (H1)

The working group (which includes 5 members of the community) has been discussing & setting up policies for dealing with planning applications, the draft is now ready to be presented to MCC in autumn for their consideration

In 2018, the group drafted a response, which was accepted by the Muckhart Community Council, and submitted to the consultation from the Scottish parliament on planning legislation in connection with development planning and management.

In connection with the new local development plan (LDP), the working group are ready to be consider the Clackmannanshire Council's Main Issues Report (MIR) which has been delayed and not clear when it will be available

# Community Development Fund/Trust (H2)

Our thanks go to the working group, which included several members of the community who brought significant experience into the discussion, and they have now completed their deliberations on what they consider to be the most suitable arrangement for our community

A discussion paper with conclusions and a recommendation for the way forward is being finalised and will be presented to the Muckhart Community Council in the autumn for their consideration.

Our thanks also go to the Development Trust Association Scotland (DTAS), have been very helpful by providing advice to the working group and who's representatives have attended two meetings within our community.

# 3. Sustainability

# **Database of Biodiversity (S1)**

# Promote and raise awareness of local Biodiversity (S3)

A Biodiversity Group of interested persons has been formed (covering both objectives). Work will be undertaken to design a suitable database which may involve a risk section (for example, to identify locally growing plants that may be a risk to native species).

Future work will involve the engagement of the school, and probably public events, to promote awareness within the community.

One of the priorities of the group is to raise awareness of Himalayan Balsam which is an invasive plant that has been identified within the local area, along the burn and around the Golf Club. Action is required to ensure that it is safely removed in accordance with current guidelines.

# Sustainable Energy and Energy Efficiency (S2)

Work has been undertaken identifying and liaising with other interested partners who can bring expertise to the community and who can offer advice on the way forward for community initiatives using renewables.

A Community Sustainability event was held last 19 September where partner organisations presented various forms of renewable initiatives, applicable to the domestic homes, and Tesla demonstrated their electric cars, and members of the community had the opportunity to drive them

A further community event is taking place on 18<sup>th</sup> September to promote home energy household initiatives (along with Fire safety)

# 4. Education

Safer routes to School (E1)
Community Volunteers, After School Clubs, promoting health & well-being (E2)
Strong support for the school, and improved access to quality Education (E3)

The Community Plan recognises the vital contribution which Muckhart Primary School makes within our local community and the primary school values the links and strong support from local community organisations and members of the community, who volunteer to provide assistance in our school.

The Parent Council are pro-actively leading on all those issues covered within the Community Plan, and MCC will fully support them in their actions, which includes working closely with the MCC Infrastructure Working Group to develop and maintain Safer Routes to School,

The "Walk to school group" now involves a panel of school children, organising activities associated with 'wellness', for example "Cycle to school". Local parents are encouraged to walk their children to school, however the use of the pub car park to drop children off and collect them was problematic as parents feel the zebra crossing on west approach to village is not safe! (as some cars do not stop)

There is no obvious solution to create more car parking at the school, due to financial constraints and lack of suitable land.

The Sustainability Working Group will be in contact with the school and the Parent Council, to discuss ways where they can assist in raising awareness on local biodiversity.

A number of initiatives identified in 2018 are coming together;

For example there is significant community volunteering at the school, although additional volunteers have been requested on website, and some afterschool clubs have been held, e.g. After school French speaking club

Muckhart Primary School are leading on an outdoor learning initiative, and plans are now coming together for an outdoor learning nursery, possibly for 2020

Councillors and MSP are regularly communicated with and involved in many issues in connection with the school which will continue.

# 5. Business Development

Improvements to broadband and cellular/ mobile services (B1)

The Business Development working Group (BDWG) which includes members from local business organisations, have met on several occasions to address issues with local broadband and cellular services and to help in identifying potential alternative solutions.

For example the group worked closely with Muckhart Golf Club to help and identify ways to improve\_broadband connectivity and performance for their members and visitors, and a solution was found through contractual changes with their broadband provider.

A number of residents are still unable to access Superfast Fibre Broadband as the provider is not prepared to fund provision of this service to the affected properties, at least in the short term and the community council has been doing everything it can to help resolve this problem by suggesting;

- The developer of H49 development encourage the provision of a new fibre cabinet located to benefit those properties not currently connected to fibre.
- The residents investigate the alternative available solutions identified by the BDWG to address poor broadband coverage together with raising the issue with our local politicians.

## Creation of web based skills register of local trades' people & professionals (B2)

The Community Council web platform now incorporates a Skills Register for local trades' persons, professionals and organisations in the form of a "Yellow Pages" where their details can be added by complete a simple on-line template.

# 6. Infrastructure

To develop a strategy to improve Road Safety within community (I1)

To develop a strategy to improve & develop foot and cycle paths for all (I2)

The Infrastructure Working Group (IWG) comprising of community council members and other interested persons from the community have been busy over the last 12 months driving the above Infrastructure objectives and making progress on the following initiatives;

# **Community Safety/Road Safety**

The Infrastructure Working Group (IWG) has made significant progress in developing a set of Road Safety improvement plans which is being progressed with the local authority and other agencies.

The Working Group's proposals include:

- Completion of current road safety improvements to the east of the village (Clackmannanshire Council have not yet competed the work commenced over 12 months ago)
- Further safe road crossing points (pedestrian crossings?)
- Reducing some 40mph speed limits to 30mph
- Improved and safer vehicle and pedestrian access to Japanese Garden, on Dollar back road, with possible introduction of 50mph speed limit from Cowden Bends to the Pool
- Initiatives to encourage compliance with speed limits
- Improved pavements and footways, especially for children walking to school bus stops
- Consideration of Safer Routes to School Initiatives
- Restricting vehicles from using Drumburn Road for through access to and from Golf Course
   Road

#### **Drumburn Road (Drumburn Farm to the Golf Club)**

After significant discussion with the various stakeholders, and with the agreement of the landowner, the Council installed bollards at either end of the path complete with all of the necessary agreed regulatory signage, which will restrict vehicles using this track for through access to and from Golf Course Road.

The owner of Drumburn Road, has confirmed that he would arrange for the path to be cleared and improved using Type 1 path construction material.

This will significantly improve the overall condition of the path and enable walkers golfers and visitors and visitors to walk safely and with ease between the village the Golf Club and beyond

# **New and Improved Footpaths & Cycle paths**

Significant progress has also been made in developing plans for new and improved foot and cycle paths and integrating these with the existing local and Clacks-wide path network. This has been done with reference to land ownership records, rights of way / access legislation, etc. and with significant cooperation from landowners, the local authority and other relevant groups and organisations.

The Working Group's proposals include:

- Improving local core paths and improving integration with the existing path network
- Improved maintenance of paths
- Improving the walking and cycling friendly route from the new Japanese Garden entrance to the A91 (now impacted by increased traffic visiting the Garden)
- New footpath from Yetts to Upper Yetts
- Improve pedestrian and cycling access along Drumburn Road (see Drumburn Road above)

## **Upper Hillfoot Road**

Discussions have taken place between MCC Officers and the Clackmannanshire Council's Access Officer & the Head of Planning, the Chair & Senior projects Officer of Enabling Projects in Clackmannanshire (EPIC) to Improving the walking and cycling friendly route from the new Japanese Garden entrance on the Hillfoot back road to the A91 (now impacted by increased traffic visiting the Garden) which would also be an extension of the walking/cycling friendly route to Dollar.

Agreement had been reached with the landowners of the southern side of Upper Hillfoot Road, stretching from Law Hill, at Dollar to the western boundary of the Japanese Garden, to progress with a new path. Initial costs and timescales had been discussed (EPIC) and potential sources of funding had been identified (EPIC and MCC).

However, due to resident concerns raised regarding the traffic access route approved by the Council for the Japanese Garden, it was agreed that further consultation was required with the landowner of the northern side of Upper Hillfoot Road, from the A91 to just short of the Japanese Garden boundary wall.

Following further discussions, this project has been put on hold, however, the Council were requested to monitor the volume of traffic using Upper Hillfoot Road, via a MetroCount system, to establish a traffic volume baseline, to help measure any increase in traffic volumes, moving forward, and to ensure that these volumes are within the guidelines specified in legislation for a Quiet Road. Unfortunately this request was turned down but will be re-investigated should concerns regarding traffic volumes be raised again.

#### Other Issues

# **Fossoway Bridge repairs**

Given the regular occurrence of accidents at, and damage to, the bridge, it was agreed that Perth & Kinross Council (P&KC) be contacted regarding the permanent positioning of traffic lights at the bridge to improve the control of road traffic, to improve road safety.

A response was received, from P&KC, stating that it was proposing to replace and upgrade the existing Vehicle Activated Sign on the A91, approaching Fossoway Bridge from the direction of Carnbo. This will illuminate a bend warning sign and a "Slow Down" message to drivers approaching the bridge and should lead to a reduction in speed. Further to the suggestions submitted, PK&C would also be investigating the effectiveness of rumble strips and dragons teeth.

# **Community Speed watch**

This initiative was reported by Police Scotland to be progressing in Clackmannan and Menstrie and MCC requested to be kept in touch regarding on-going developments.

# **Speed Signs:**

It was that Perth & Kinross Council (P&KC) were deploying more road traffic signs which measure and display a vehicle's speed and that these signs appeared to be effective at controlling speeding. MCC agreed that the Council should consider deploying these types of signs in the Muckhart area and this will be progressed, once a new Traffic Management and Road Safety Officer is appointed and will be included in any relevant representations made.

#### 20MPH Bill:

A response to the Government consultation on the Restricted Roads (20 mph Speed Limit) (Scotland) Bill was prepared, agreed and submitted on 28<sup>th</sup> January, on behalf of MCC.

# **Government survey on the value of local roads**

A response was prepared, circulated for approval and uploaded, on behalf of MCC.

# **Electric vehicle charging infrastructure**

Contact with the Council's Transport Officer confirmed that potential charging points would require to be located in public areas with a reliable mobile communications signal.

MCC agreed that the Council owned parking area, opposite the Coronation Hall, would be proposed as the preferred site for an initial charging point for the village with future consideration given to the proposed visitor area at the Church.

# 7 Active Community

# Establish an integrated community Electronic Infrastructure on MCC web platform (A1)

Jonathan Bacon has made excellent progress in developing the Community Council's web-site into a community web platform which links with other community organisation's web-sites or provides a web page for them to promote their organisation.

The Web Platform now includes;

- A community diary for local events
- A "Yellow Pages" section for businesses to promote their trade or services
- A Welcome Pack for those new to the village
- Latest community news and events
- List of latest road closures or roadworks
- Details of other community groups (including contact details)
- Helpful advice for completing an application for funding

# 8 Public Service

# Develop a strategy aimed at improving Public Transport for the local community (P1)

Philip Lord has been liaising with Clackmannanshire Community Transport Association and has attended various meetings hosted by Keith Brown.

It is acknowledged that it is difficult for a small community to have much influence on bus services travelling to and from locations out with Clackmannanshire, however, efforts will concentrate on improvements to the DRT system and Emphasis is now on working with partners in wider area (e.g. Kinross and Dollar) to determine a wider transport Strategy for area.
